## PROJECT BACKGROUND AND PURPOSE


The South Carolina Department of Transportation (SCDOT) along with the Spartanburg Area Transportation Study (SPATS) identified the intersection of SC 56/Asheville Highway & SC 85 Business (Hearon Circle) in Spartanburg County for improvement based on the

intersection experiencing significant congestion with a history of frequent collisions.

SCDOT selected local engineering firm Stantec to analyze and evaluate safety and traffic conditions of the Circle to determine potential safety and operational improvements on roadway approaches and through Hearon Circle. The analyses of the 10-year historical crashes at Hearon Circle revealed most crashes were of the rear-end type which included high frequency clusters at:

- SC 56/Asheville Highway between SC 56/Asheville Hwy and the SC 85 Business northbound on-ramp
- Southeast bound approach to the Circle along SC 56/Asheville Highway and
- near the northbound approach of Simuel Road at the Circle.

## **PROJECT LOCATION**




# PROJECT CRASH DATA

- From 01/01/10 to 12/31/20 there were 1546 total crashes with 206 (13%) resulting in injury
- Rear end crashes at the Circle were the most common with nearly 80%
- 60% of crashes occurred between 12 PM and 5 PM

## **PROJECT DESCRIPTION**

The proposed design is to close and reconfigure various approaches to Hearon Circle such that the existing roadway width within and approaching Hearon Circle can be reconfigured to improve operation, safety, and driver expectation:

- Maintain two circulating lanes on north and south legs of the circle but provide single circulating lanes on east and west legs of circle.
- Close the Simuel Road approach to Hearon Circle.
- Convert SC 85 Bus SB off-ramp/Charisma Drive to one-way flow entering the circle and terminate Charisma Dr. north of the SC 85 SB off-ramp.
